

Privacy Policy

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You. We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

Administrator, Dolineo – Dolineo Sp. z o. o. with its registered office in Lublin at Wojciechowska 7E, 20-704 Lublin, registered in the register of entrepreneurs kept by the DISTRICT COURT LUBLIN-WSCHÓD IN LUBLIN WITH THE REGISTERED OFFICE IN ŚWIDNIK, VI COMMERCIAL DEPARTMENT OF THE NATIONAL COURT REGISTER under KRS number 0000794489, NIP: 9462690268, REGON: 38386354300000, share capital in the amount of: PLN 50,000, e-mail address: kontakt@nosilo.io, tel. 22 854 20 60

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to private limited company, Wojciechowska 7E, 20-704 Lublin, Poland.

Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Country refers to: Poland

Customer – a natural person, a legal person, an organisational unit without legal personality, conducting business activity, or another entity that, pursuant to an agreement concluded with Dolineo for the provision of e-learning product sharing services and under which Dolineo provides users with access to e-learning product sharing services.

Account means a unique account created for You to access our Service or parts of our Service.\

Policy - this Privacy Policy;

Regulations - Regulations for the provision of Services electronically on the Website;

GDPR - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC

Session - the period of use (entry) by the User of the Website;

Website – Dolineo website, operating at the following addresses: [nosilo.io];

External websites - websites of the Administrator's partners, service providers or service recipients;

Device – an electronic device with software through which the User gains access to the Website;

Services – Services provided by Dolineo on the Website;

Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

Act on the provision of services by electronic means - Act of July 18, 2002 on the provision of services by electronic means (consolidated text: Journal of Laws of 2020, item 344).

User – any natural person visiting the Website or using one or more Services or functionalities of the Website.

§ 2 General provisions

1. The owner of the Website is Dolineo.
2. In order to use the Website and provide Services, Dolineo collects and processes Users' data.
3. Dolineo - in accordance with the GDPR - is the administrator of personal data processed within the Website.
4. The Policy sets out the rules for the processing of personal data and data contained in Cookies on Devices for the purposes indicated in the Policy.

§ 3 Purposes and legal basis for data processing by Dolineo

1. **In connection with the operation of the Website, the following User data is collected:**

1.1. Data collected automatically using Cookies

During the User's visit to the Website, data is automatically collected, in particular identifying markings (login or other assigned by the operator), IP address, browser name, operating system, information about the beginning, end and scope of each use of the Website. and the services available there.

The legal basis for this data is detailed in § 4 of the Policy.

1.2. Data provided by Users to provide information about e-learning products

On the Website, through various functionalities of the Website, the User can contact Dolineo, at the same time providing their contact details in order to provide information about e-learning products (in particular: chat service, contact form, "contact us" function).

Legal basis for the processing of personal data in this regard it is necessary to process data to conclude and perform the contract for the provision of the Service of providing information on e-learning products (Article 6(1)(b) of the GDPR), and in the scope of data provided optionally, the legal basis for processing is the User's consent (Article 6(1) of the GDPR). letter a GDPR). Additionally, the basis is the legitimate interest of Dolineo in order to establish, pursue or defend claims (Article 6(1)(f) of the GDPR).

1.3. Data necessary to use the Account

The Website processes data provided by Users when using the Account. These data are provided voluntarily when logging in, but providing them is necessary in order to use the Website.

The legal basis for the processing of personal data in this respect is:

- 1.3.1. in the case of the Demo version - conclusion and performance of the contract for the provision of the Service of providing e-learning products (Article 6(1)(b) of the GDPR), and in the scope of optional data, the legal basis for processing is the User's consent (Article 6(1)(b) of the GDPR). Additionally, the basis is the legitimate interest of Dolineo in order to establish, pursue or defend claims (Article 6(1)(f) of the GDPR);
- 1.3.2. in the case of the Dolineo System - an agreement for entrusting the processing of personal data concluded with the Customer (Article 28(3) of the GDPR).

1.4. User's data for Dolineo's marketing purposes

User's data is processed for Dolineo's marketing purposes and for the purpose of transmitting commercial information using means of distance communication (telephone, text message, e-mail), provided that the User expresses his/her consent. The User is entitled to withdraw consent at any time by sending information to the contact details indicated in the information clauses or the Policy.

The basis for the processing of personal data in this respect is the implementation of Dolineo's legitimate interest in the promotion of Dolineo services using telecommunications terminal devices and automatic calling systems - if the User has consented to such contact (Article 6(1)(f) of the GDPR, Art. 10(2) of the Act of 18 July 2002 on the provision of services by electronic means and Article 172(1) of the Act of 16 July 2004 Telecommunications Law).

1.5. Data of people visiting Dolineo profiles on Facebook and LinkedIn

Dolineo processes personal data left by people visiting Dolineo public profiles on Facebook and LinkedIn (including likes and comments).

The basis for the processing of personal data in this respect is the implementation of DOLINEO's legitimate interest in the promotion of DOLINEO services and for the purpose of establishing, pursuing or defending claims (Article 6(1)(f) of the GDPR).

2. The recipients of personal data are entities processing personal data on behalf of DOLINEO, including: IT service providers and branding agencies - such entities process data on the basis of an agreement with DOLINEO and only in accordance with DOLINEO's instructions. The recipients ensure appropriate protection of Users' data - they are entities based in the European Economic Area, and in the case of entities based in the USA - DOLINEO has appropriate contracts concluded with them. DOLINEO will not process personal data outside the European Economic Area to any extent other than in the preceding sentence.

3. Users have the following rights in connection with the processing of personal data by DOLINEO:
 - 3.1. the right to access your personal data;
 - 3.2. the right to rectify your personal data;
 - 3.3. the right to delete your personal data;
 - 3.4. the right to limit the processing of your personal data;
 - 3.5. the right to transfer your personal data;
 - 3.6. the right to object to the processing of personal data if the processing is based on the legitimate interest of DOLINEO;
 - 3.7. the right to lodge a complaint with the supervisory authority;
 - 3.8. the right to withdraw consent to the processing of personal data on an optional basis at any time;
 - 3.9. the right to withdraw consent to receive commercial information from DOLINEO and to be contacted by phone (including via SMS) at any time.

4. The User may exercise his/her rights by contacting DOLINEO (contact details indicated in § 1 point 1 of the Policy).

5. 5. The period of data processing by DOLINEO depends on the type of service provided by DOLINEO and the purpose of processing. Users' personal data will be processed for the duration of the contract between DOLINEO and the User, and then until the expiry of the limitation period for claims provided for by law or until the User exercises his rights referred to in point. 3 above. If Users' personal data are processed by DOLINEO on the basis of a personal data processing agreement concluded with the Customer, the personal data will be processed until the date of termination or expiry of the indicated personal data processing agreement.

6. After the processing period, the data is irreversibly deleted (including anonymized).

7. Providing personal data by the User is a condition for concluding or performing the contract concluded between DOLINEO and the User or Dolineo and the Customer or is necessary to provide the functionality of the Website or branding information to which the User has consented.

8. To the extent that personal data were not obtained directly from the User - DOLINEO obtained the User's personal data automatically through the functionalities of the Website or Dolineo obtained them from the Customer.

§ 5 Acceptance of Cookies used on the Website

1. During the first session on the Website, the User is entitled to choose the Cookies used on the Website. The User can accept all Cookies or select them at his discretion.
2. The User may at any time change the settings for saving, deleting and accessing data stored in Cookies. The user can also completely block cookies. The User may delete any cookies saved

so far at any time. The effect of making the changes referred to above may be the loss of the ability to use some functionalities of the Website.

3. Information on how to disable Cookies in the most popular computer browsers and mobile devices is available on the following websites:

 - 3.2. Cookies in the Chrome browser;
 - 3.3. Cookies in Firefox;
 - 3.4. Cookies in the Opera browser;
 - 3.5. Cookies in the Safari browser;
4. Failure to make the choice referred to in section 1 above and the changes referred to in section 2 above means that Cookies will be placed on the User's device in accordance with the User's settings and selection, and thus DOLINEO will store information on the Device and gain access to this information.
5. DOLINEO shall not be liable for incorrectly functioning functions of the Website if the User limits in any way the ability to save and read Cookies.

§ 6 External websites

1. The Website may contain links to other websites. Such websites operate independently of the Website and are not supervised by the Website in any way. These websites may have their own privacy policies and regulations, which DOLINEO recommends reading.

§ 7 Security

 - 1.2. External cookies - the Administrator is not responsible for the security of cookies from the Website's partners. The list of partners is included in § 6 section 2 Policy.

§ 8 Changes to the Policy

1. DOLINEO reserves the right to make changes to the Policy, in particular due to the development of Internet technology, possible changes in the law regarding the protection of personal data and the development of the Website.
2. DOLINEO will inform about any changes in a visible and understandable way by placing information about the change on the website where the Policy is posted.
